Concern

Agencies are not sufficiently educated about funding opportunities and processes and there is a lack of communication and coordination of planning priorities for Navajo construction projects. There is limited discussion at State Transportation Board meetings about state route projects through tribal land. Another concern is that tribal graduate students do not return to the Navajo Nation.

In order to effectively pursue safety funding for projects on Navajo Nation as a partnership we need to have and share traffic crash data to support funding. NDOT and ADOT use different systems and they are not compatible.

Norma Bowman		Not ready to make this request as still in the process of finalizing data, forms and coordination. ADOT finalized the crash data forms which are on the ADOT website. The next step is to review them with the Navajo Police Department. Tim Jordan, Ermalinda Gene, Arlando Teller and Norma Bowman may be involved in these discussions. Tim Jordan, ADOT, and other ADOT staff, are considering having a meeting to discuss how to coordinate with the tribes. Ultimately, the crash data form will need to be entered into the ADOT system (TraCS software) and permission needs to be granted to allow ADOT to use the information. Dir Halikowski is currently working with the governor's office to address language in the IGA contract that would help remove barriers between the tribe and its access to the software. Some smaller steps still need to be completed. 1. Tim Jordan will be meeting with various police depts. to demonstrate TraCS and review the new crash data form. 2. Tim is considering doing a demonstration of the
