Opening Prayer & Welcome

Hubert Lewis, Governor of Moenkopi Village provided the opening prayer. He welcomed the group to the Village and also expressed appreciation for attendance by officials from the Navajo Nation. He is glad to see everyone come together to discuss transportation needs for this area of the state.

Opening Remarks

Mike Lomayaktewa, Hopi Department of Transportation Director, thanked everyone for attending and spoke about changes to the agenda due to unexpected conflicts. He thanked Governor Lewis for his attendance and thanked the manager of the Moenkopi Legacy Inn for providing the meeting room, audio/video equipment and refreshments. He also read a message from Hopi Chairman Herman G. Honanie which emphasized that the group strive for increased safety and mobility, keep a strong partnership and work to make improvements to our transportation systems. The Chairman's full message is posted on the Partnership webpage.

Introductions, Meeting Agenda Overview & Partnering Evaluation Program (PEP) Process Rating

Julia Voight, ADOT Facilitator, reviewed the agenda and then introductions were conducted. The PEP process was discussed and attendees completed their evaluations of the working relationship of partnership members over the past year. The meeting sign-in sheet is attached to these notes.

Partnership Working Group Focus

Mike Lomayaktewa thanked everyone for their work to plan this meeting and thanked those in attendance for taking the time to attend. He explained the evolution into a working group and the goal established for implementation. The change in focus has allowed the group to ensure all meetings are productive.

Don Sneed, ADOT Planner/Tribal Liaison, commented that based on Partnership Steering Committee recommendation four goals were considered for implementation during the 2014 Partnership Annual Meeting, they included: (1) Increase transportation safety, (2) Understand ADOT planning and programming processes, (3) Pursue and provide training and technical assistance, and (4) Understand partner and interagency processes. After going through a SMART Goal exercise it was agreed that considering time and effort needed to make progress only the goal to "Increase transportation safety" would be the focus of the partnership for the next several years. Subsequently sub-goals, measurements and action plans were created to guide the next steps. Don also noted that the partnership previously consisted of a Steering Committee that met three times per year to work on a wide range of goals and action plans. This method was not achieving progress in a timely manner, so the structure was changed to a smaller working group format.

2015 Goals Implementation Plan – Status Report:

Don Sneed reviewed the status of the 2015 Goals Implementation Plan. Detailed information reviewed on the Plan is presented on page 4 and the Plan document is posted on the Partnership webpage. The goal and subgoals are listed below:

Overview of FHWA Activities; Reauthorization; and Traffic and Criminal Software (TraCS) Program

Romare Truely, FHWA Arizona Division Community Planner/Tribal Coordinator, spoke about the federal TIGER Grant the Hopi Tribe received. He emphasized that it is important for the Tribe to identify funding for the utilities portion of the project. The deadline for the information to be submitted is in February 2016. If this deadline is not met, the Federal funds will be reallocated. The FHWA contact for this is Ammon Heier.

Romare also spoke about the importance of having an integrated database for all agencies to access accurate and reliable safety data. The TraCs Program will be a great way for the Tribe to be able to provide crash data, which would increase the possibility of safety funding on Hopi land. The software is free and Kelly LaRosa at the FHWA Arizona Division office will be able to provide more information.

Darryl Bradley, Navajo DOT Acting Division Director, commented that the Navajo Nation received a safety grant to implement the TraCs Program and that full buy-in from the Public Safety sector is critical.

Don Sneed suggested that Rick Turner with the ADOT Traffic Records Section should be requested to provide a presentation that will give the Hopi Police Department more understanding on how the program works and the benefits of using it.

It was noted that a data sharing agreement will be needed in order to implement use of the TraCS Program. A link to the FHWA contact page is https://www.fhwa.dot.gov/azdiv/staff.cfm

Hopi Tribe Long Range Transportation Plan

Mike Lomayaktewa provided an overview on the development of the Hopi Tribe Long Range Transportation Plan. Finalization of the Plan is pending Tribal Council approval. Mike noted that due to recent changes within the Hopi communities there is already a need to update the Plan. Another issue is regarding the recent storm which caused the need to divert school buses resulting in impacts to students and the need to assess school bus routes. Mike's presentation is posted on the Hopi Partnership webpage.

Hopi Strategic Highway Safety Plan

Lt. Willis Sequi from Hopi Resource and Enforcement Services spoke about the calls his agency deals with and various traffic statistics. Since 2011, calls have increased from approximately 800 per year to over 4,000 in the first three quarters of 2015. On Hopi there have been five fatalities with two being alcohol related so far this year and there were 300 DUI stops so far this year. Passenger ejections at crash sites are also a major issue. Law enforcement wants the TraCs System and told the Village representatives he is glad they are in attendance. He needs their help to get the TraCs system in place and also to implement and educate on the Hopi Strategic Highway Safety Plan. Sharing information with the State and County partners will not be giving up sovereignty; it will be providing information to enable Hopi to obtain grants and funding needed to help with their safety plan.

Hopi Tribe Non-Emergency Medical Transportation - Rules and Regulations

This agenda item was not conducted due to an unexpected circumstance.

Role of the Arizona Department of Public Safety in Highway Safety

Captain Ezekiel Zesiger of the Arizona Department of Public Safety (ADPS) spoke about the Arizona Strategic Highway Safety Plan (AZ SHSP) and his agency's goal to reduce collisions. He mentioned that non-restraint is a huge issue. He discussed who is responsible for the various types of crashes considering cross-commissioning of

state troopers to enforce tribal laws. He also reiterated previous discussion on the value of the TraCs system from the perspective of ADPS. They are able to analyze data from the system to help cater their enforcement to the areas in need. The AZ SHSP is based on the data they have gathered from the TraCs system. It is possible for the Hopi Tribe to request additional enforcement for special events when traffic increases on state routes. He also encouraged tribal members to apply to work with the ADPS. Captain Zesiger's presentation is posted on the Hopi Partnership webpage.

Hopi Senom Transit

Donovan Gomez, Director of Hopi Senom Transit, spoke about the Hopi Senom Transit mission, vision, scope of work and specific details about their services. He spoke about their goals and current actions to achieve their goals. Specifically he is looking to hire a 4th driver and the Flagstaff route is the most popular. He mentioned that the transit system is pursuing development of a vehicle maintenance facility. He also inquired of ADOT if it was possible for the transit vehicles to fuel up at the ADOT Keams Canyon fuel site. He then asked ADOT to consider the provisions given to tribes and the government-to-government relationship to help this program locate funding to meet their needs and concerns. Future discussion with ADOT will need to be scheduled on the aforementioned topics. Mr. Gomez' presentation is posted on the Hopi Partnership webpage.

FHWA/ADOT Section 106 Programmatic Agreement Update

Ruth Greenspan, ADOT Cultural Resources Program Manager spoke about the requirements of Section 106 and the development of a programmatic agreement (PA) between ADOT and FHWA Arizona Division for federal-aid highway projects. However, it does not include projects using funding from the Federal Lands Division. All Arizona tribes are being consulted regarding this PA. Because the ancestral Hopi land is much larger than their actual land holdings, ADOT actually consults with Hopi on projects across the state. Because of this, there have been discussions about creating a separate PA for the Hopi. If Hopi is interested in this they can contact Ruth for further discussion. Other identified follow-up items include: Keep the Partnership informed on the PA process; Update the ADOT cultural areas map for Hopi and all other tribes; Include HDOT in consultation through coordination with the Hopi Cultural Resources Office; Mike Lomayaktewa to work with the FHWA and Hopi Cultural Resources Offices for projects on state routes. Ms. Greenspan's presentation is posted on the Hopi Partnership webpage.

Partnership Group Updates

- Hopi DOT
 - Mike Lomayaktewa spoke about the Hopi Department of Transportation Mission Statement, Goals and Objectives, Coordination/Linkages, and the Results/Accomplishments for FY 2015. He also reviewed planned projects for FY 2016. His presentation is posted on the Hopi Partnership webpage.
- Navajo DOT
 - Darryl Bradley, Acting Division Director for the Navajo DOT, spoke about the Vision and Mission of the Navajo Division of Transportation. He also gave an update on the road inventory on the Navajo Nation and the major accomplishments for the year. Mr. Bradley provided a summary on the status of Navajo DOT projects which is posted on the Hopi Partnership webpage.
- BIA DOT
 - Garrett Silversmith, Supervisory Highway Engineer for BIA spoke about the work his group does for maintenance. He provided an update on route 8031, the route from Pinon west to the Hardrock Community. This dirt road is not very wide and has deep ruts and cliffs. The upgrade of this 13.5 mile road is in the design phase that should be completed by February 2016. There are 14 newly discovered

archaeological sites which may force rerouting the road and will increase the cost of the design. The project will cost approximately \$22 million for the Navajo side and \$11 million for Hopi the side.

Hopi DOT Group Exercise

 Hopi DOT staff presented several logo designs that they have received as options for the Department and asked the attendees for their opinion about the one they preferred. The large logo was chosen for road maintenance and the small black and white was chosen for the DOT; however, the group agreed the black and white logo should be in color.

Coconino County

o Scott Tkach, Coconino County Engineer, spoke about the number of miles on Hopi land and Navajo land and situated within Coconino County. His agency only provides road maintenance services and limited work has been conducted on Hopi land. He mentioned the County has acquired additional money (i.e. 1-cent sales tax) to be used for maintenance on County roads. The agreements in place only allow for blading the roads, no drainage or other types of work. He encouraged both groups to develop a 5-Year Capital Improvement Plan which will help the County manage the funds allotted to roads on Hopi or Navajo. The County is doing a lot of pavement preservation this year. It is also updating its engineering standards which may be used by other agencies. If the Tribes are interested in participating on the stakeholders group they can contact Scott. The County is also working to establish a drainage maintenance group that will work on drainage standards.

Navajo County

O Jesse Thompson, Navajo County Supervisor, spoke about working closely with the Hopi Tribe, Navajo Nation and White Mountain Apache Tribe. Navajo County has supplied equipment, materials and technical assistance to the tribes and will continue to do so. It has provided sandbags to prevent flooding and assistance for blading roads. There are agreements in place that dictate how they work together and agreements will continue to be developed. Supervisor Thompson provided a handout describing County-Tribal accomplishments; the handout is posted on the Hopi Partnership webpage.

ADOT Northeast District

- Lynn Johnson, ADOT Northeast District Engineer, spoke about reorganization within ADOT. Engineering District boundaries, accounts payable system, hiring system and many other business practices have changed. Lynn shared information about the upcoming ADOT projects on Hopi lands. His District will monitor drainage issue areas on SR 264 and SR 87. He mentioned that funding for ADOT is diminishing and prioritizing projects becomes very difficult. Lynn spoke about Key Commerce Corridors and how these corridors will be the focus of funding projects for ADOT. However, the northeast corner of the state does not include a Key Commerce Corridor route. Mr. Johnson provided a handout listing current and FY 2016 construction projects within his District, the list is posted on the Hopi Partnership webpage.
- A comment was made by Sandy Whitehair of Shungopavi Village that there are safety concerns on SR 264 in particular regarding near misses with children crossing the highway and the lack of signage. She plans to send a letter to Mr. Johnson requesting a meeting to further discuss the issues.

2016 Partnership Direction and Next Steps

Julia Voight and Bonnie Opie wrapped up the day by asking if any information should be incorporated into the working group's goals based on the meeting discussions. The following information was captured from multiple attendees and should be included in the Partnership Working Group's focus in 2016:

Several recommendations were made regarding things that could be done to prepare for addressing safety improvements and to obtain funding.

- Road Safety Assessments (RSAs) should be completed for SR 264.
 - o Information for areas identified for an RSA should be sent to Lynn Johnson. He asked that the route be divided into manageable sections by mile post and that a description of the concern be included. He will take that information and submit it through the proper channels.
- Planning Assistance for Rural Area (PARA) studies should be considered.
 - o Don Sneed has information about this process.
- Consider conducting a field trip to look at specific areas where safety improvements are needed.
 - o Ensure the correct people are able to attend.
 - o Coordination with the Hopi Villages will be required.
- Implement the TraCs system.
 - o Obtain information and work on implementation.
 - o Include tribal leadership, seek support and explain the importance.
 - o Also include the Tribal Council, public and any others identified during discussions.

The Hopi Senom Transit is in dire need of a maintenance facility and requested assistance. Two options were provided for equipment maintenance and repair until a facility can be secured.

- ADOT Equipment services will contract with Hopi Senom Transit to provide equipment maintenance and repair. Contact Lynn Johnson for information.
 - The BIA in Chinle will also contract with Hopi Senom Transit to provide major equipment repair. Garret Silversmith or other BIA staff can be contacted for information.


